

# The Sarah Morgan Foundation: Funding Application Form & Award Criteria

The Sarah Morgan Foundation was established in 2013 to continue the work of Dr Sarah Morgan, promoting the inclusion of English traditional/folk song in the community choir repertoire and in a broader artistic, social and educational context.

Individual awards are made up to the value of £500.00\* at the discretion of the Trustees, who assess applications as they are received throughout the year. Successful applicants will be required to produce a detailed End-of-Project Report (including media for use on the Sarah Morgan Foundation website and media channels) once the project has concluded and prior to release of award funds. # The Sarah Morgan Foundation Grant Scheme

## Objective

To provide financial help to individuals or groups wishing to promote the inclusion of English traditional/folk song in their community choir repertoire or group project (e.g. a group/choir to commission an English folk song to be arranged, or publication of a book of folk songs arranged for community choirs, etc.).

## Assistance Available

The Sarah Morgan Foundation has limited funds. A maximum of £500.00\* will be granted to any one project. Successful applicants would be requested to provide a material benefit to the Sarah Morgan Foundation - in the form of photos of the project for the website, wider publicity etc. – and if generating income (e.g. through sales of resources), may be requested to contribute a percentage of sales to the Sarah Morgan Foundation.

## Application Process

Applications must be in writing (either by email or post) and **can now be made at any time during the year**. Applicants will be notified when the Trustees have reached an initial funding decision and subsequently issued with a formal Acceptance Letter.

## Conditions of the Award

- The award must be acknowledged in all publicity (in accordance with our supplied guidelines)
- A detailed End-of-Project Report, including photo/audio evidence when relevant, must be supplied by the applicant upon conclusion of the project, ideally in a format for inclusion on the Foundation's website and/or media channels. Appropriate permissions for public use by the Foundation of any images submitted must be sought and confirmed by the applicant
- Award funding will be paid after submission of the End-of-Project Report, subject to assessment by the Awarding Committee. In certain circumstances, part funding may precede the start of the project.

## Adjudication

- Applications will be judged on the merits of the project
- All applicants will be notified whether successful or not
- The decision of the Awarding Committee will be final and not subject to any right of appeal

## **The Sarah Morgan Foundation: Funding Criteria**

1. The project should demonstrate clearly and comprehensively the inclusion or development of English traditional/folk song in the community choir repertoire or in a broader educational context.
2. The project should be underpinned by the principles of musical inclusivity, e.g. open access to all; no requirement for formal musical training barring participation.
3. Applicants should provide a clearly costed project proposal, with timescale of project development / delivery and outline of what efforts have been made to secure other sources of funding (where applicable).
4. Applicants must demonstrate a clear understanding of the vision and objectives of the Foundation.
